Administrator's Corner

The Board of Selectmen and town employees were saddened by the news of Jim Mitchell's passing. Jim was an integral part of our community and will be greatly missed.

Audio Recordings of Meetings - The Selectmen have been working with both the petitioner of warrant article #26 and the various committees in order to formulate an agreeable policy which deals with the audio recording of meetings. Chairmen of committees and the Selectmen will discuss this at their June 24th meeting. It's important to note that although the audio recordings are not yet on our website, copies can be obtained in the Selectmen's Office.

Transfer Station - Recently, much of my time has been spent working with Allan Brown, the highway department crew and the transfer station staff in order to come into compliance with deficiencies sent forward from the Department of Environmental Services with regard to the Transfer Station. A complete list of deficiencies is available in the Selectmen's Office. The major items deal with hazardous fluids, containment vessels and household hazardous waste.

Due to the clean up activity, various rumors have cropped up stating that there are drastic changes being made and that the transfer station is being set up to fail. This is not the case. Regardless of the rumors, single stream recycling is not being implemented and in fact, the Selectmen have stated on more than one occasion that although they may place the subject matter on a future warrant for a vote of the town, they are very happy with the way Warner recycles. Additionally, the Selectmen are not selling or getting rid of the horizontal baler or any other major equipment at the Transfer Station. Residents can rest assured that nothing has

changed with regard to the materials that have always been accepted for recycling (plastics, cardboard, cans, etc.). However, until we come into compliance with DES, the acceptance of household hazardous waste has been suspended. Since the front gate is closed when the facility is not open to the public, contractors wishing to dispose of construction debris may make arrangements to come in during those hours simply by calling ahead.

Moving forward, employees will continue working on the DES deficiencies and refresher training for the staff will take place with regard to the Town's Solid Waste Ordinance. There will be a public meeting scheduled in which DES will offer a presentation on best management practices which will be informational to the public and staff. The Selectmen will be evaluating all of the programs in order to make sure the facility is operated in the most efficient and cost effective manner possible. Suggestions from residents are always welcome and can be either emailed to the addresses at the bottom of this page or sent to the Selectmen's Office.

It's important to remember that the transfer station employees deserve to have a transition free from political distractions so that they can remain focused on the job at hand. Both the transfer station and the highway department staff continue to do a professional job as we work on addressing issues which were identified by DES in the timeframe allotted. I'd like to thank all of them for their hard work and to acknowledge Pete Newman's departure from our staff. Pete will be missed and we all wish him well in the future.

Quite a few residents have stopped by or called with positive comments. Change is never easy but their encouraging words have helped a great deal - thank you.

News from the Assessing Office

Our feature this newsletter is the Veterans' Tax Credit. To be eligible for the Veterans' Tax Credit you must have served 90 days of active duty (service in basic training, National Guard, or Reserve Units do not count as active duty) during certain periods of time which are listed below:

WWII December 7, 1941 - December 31, 1946

Korea June 25, 1950 - January 31, 1955

Vietnam December 22, 1961 - May 7, 1975

*Vietnam July 1, 1958 - September 1, 1961

* This period requires both 90 days active duty and a qualifying medal.

Gulf War August 2, 1990 - current (no closing date has been proclaimed)

The veteran must have an honorable discharge, must be a New Hampshire resident for at least one year prior to April 15th of the year applying, and must provide a copy of his or her DD214 for verification of dates. LOW AND MODERATE INCOME HOMEOWNERS' PROPERTY TAX RELIEF

This program is a State program. To qualify, you must own a homestead subject to the State education property tax, reside in such homestead on

April 1 of the year for which the claim for relief is made, have a total household income of \$20,000 or less if single, or \$40,000 or less if married or head of household. The forms are available at the Tax Collector's and Assessing Office. **This form must be postmarked and mailed to the State no earlier than May 1, 2008 and no later than June 30, 2008.** If you have any questions, please call Martha Mical at 456-2298 ext. 3.

News from the Planning Board

Aside from regular business the Planning Board has been at work updating the Town's Master Plan. The process is expected to take approximately one year to eighteen months for completion. A survey has been finalized that will be sent to all residents and businesses this summer. This will be the first important step to get the process underway. In the meantime, the Planning Board is reviewing all current regulations and is also assembling data collected since 1999 regarding population, new buildings and other changes within the Town. As the Planning Board moves further into the process everyone will see and hear more information. Along with the survey results, the Planning Board will be looking for more public input through scheduled informational hearings as well as through this medium.

News from the Fire Department

The Warner Fire/Rescue participated in the "Spring into Warner" day. The Fire Station was opened to all, and about 40 children and their parents came to visit. The children received fire hats, balloons and stickers and got to sit in the fire trucks. Smokey the Bear showed up and greeted everyone. Do you know Smokey's middle name? (The!)

The Girl Scouts from Troop 282 presented Fire Chief Richard Brown with a poster and boxes of Girl Scout Cookies and proclaimed the Fire Department as their "Hometown Heroes." He may conduct health inspections of public places, child care and foster home locations, monitor health and sanitary conditions in the community and coordinate tests for water and septic

Building Permits

Any owner or authorized agent who intends to construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, enlarge, alter, repair, remove, convert or replace any electrical, gas, mechanical or plumbing system, the installation of which is regulated by the State Building Code, RSA 155-A, must obtain a Building Permit

News from Emergency Management

A community wide Hazardous Mitigation Planning Committee, comprised of Town Emergency personnel, local officials, Business Association members and citizens are reviewing and updating our previous approved Hazardous Mitigation Plan. This update will enable the Town of Warner to maintain eligibility for reimbursable disasters should a natural disaster occur. Community leaders will be able to update goals and action for reducing the impact of hazards such as flooding and ice storms to Warner's people, buildings, and land.

The Committee will hold their next meetings on Mondays, June 23 and June 30 at 1:00 PM at the Town Hall, 5 East Main Street. Future meetings in July and August will be to discuss the Plan and to solicit public feedback on the document. All are invited to attend and participate.
