Administrator's Page

The summer is winding down and our largest project of the summer, Connors Mill Bridge, is completed and opened. We have been fortunate this year to have work crews from Merrimack County Corrections assist with field cleanup, road sweeping and building a storage area at the Highway Department. Utilizing these programs (bridge aide and work crews), saves Warner taxpayers money and enables us to do more projects with the money we do have.

We continue to strive to improve communication with residents and have joined forces with the Library to keep an updated calendar of events which you will read about in this newsletter. We're also using Twitter to send out information to followers about board and committee meetings. This will also be used in the event of an emergency as another (free) form of communication so that we can get information to residents as we receive it. This avenue was used successfully during the ice storm by other entities and individuals to keep in contact and relay information. Our Twitter account name is WarnerNH03278 if you're interested in following us.

We're in the beginning stages of the 2010 budget season and each department is working at pulling their budgets together. The Selectmen have been proactive after receiving the news of reduced revenues from the State as a result of their budget passage. In 2009 the Town will not receive \$35,000 in revenues which translates to an approximate 11 cent tax impact. The Selectmen have reviewed the 2009 budget and have identified areas that may be underspent, barring any emergencies, in order to make up the shortfall thus preventing a tax impact to the residents. As we move forward with the 2010 budget, please feel free to follow the progress by attending Selectmen and Budget Committee meetings.

The Zoning Board of Adjustment is in need of alternate members. If you are interested in serving on this Committee, please call the Selectmen's Office at 456-2298 ext. 2.

From the Board of Selectmen

The Concord Regional Solid Waste Cooperative's proposed single stream recycling facility is on "hold" for the time being. The Co-op's Joint Board of Directors met on August 20, 2009, ostensibly to hold a critical "go/no go" vote. A "yes" vote would mean the Co-op would proceed with the construction of the single stream facility. A "no" vote would put the project on an indefinite hold. As it turned out, no vote was taken at all as to whether to build or not to build. Too many questions remain unresolved.

Warner's representative to the Co-op, Selectman David Hartman, was prepared to vote "no" if the question had been brought to the floor. The Board of Selectmen voted at its August 18th meeting to support such a vote. Especially worrisome is the fact that the tonnage that the Co-op has lined up to utilize the facility falls far short of what is expected to make the facility pay for itself. As of Co-op meeting night, only 18,662 tons of recyclables had been lined up. Planners for the facility claim that they need at least 30,000 tons per year to make a go of it. They would like to see many thousands of tons more.

A second and equally important issue is whether the current financial plan would be able to replenish the capital reserve fund of \$13,000,000 to be used to build the facility. This fund has been built up over the past 20 years of the Co-op's life in expectation that it would be drawn on to build a new landfill at some point in the future when our existing landfill in Franklin is used up. In fact, the planners are now counting on not paying back the fund in order to make the recycling fees be competitive with those of other recycling operations available to Co-op members. Even the Co-

op's consultant agrees with Warner's representative that this is a "foolhardy" proposition.

Where the Co-op's interest in single stream recycling goes from here is questionable. The *Concord Monitor* reported recently that the Concord City Council had the same reservations about the proposal as does Warner. Without Concord's endorsement, the future of the Co-op's single stream recycling facility is in jeopardy.

From the Odd Fellows Building Committee

The Warner Board of Selectmen and the Odd Fellows Building Committee recently accepted the final report from its consultant, T.F. Moran, on the feasibility of redeveloping the Odd Fellows Building. The study, funded by a \$12,000 grant from the Community Development Block Grant Program, evaluated alternative uses of the building, such as office, retail/commercial and residential, in terms of limitations and measures necessary to comply with Town and State building/fire codes. Parking requirements were also considered. The study recommended that residential use would be the most suitable use of a redeveloped Odd Fellows Building, with twelve, two-bedroom apartments intended for workforce housing. Also identified in the study were a set of funding sources that would be available for this type of project. The Town has sent out requests for letters of interest from private and non-profit developers, due the end of August, to move to the next step in the building's rehabilitation. The Committee is also working to line up local financing to cover portions of the mansard roof with roll roofing as a temporary fix to prevent further leaks. Copies of the Feasibility Study may be viewed at the Selectmen's Office or at the Pillsbury Free Library.

From the Conservation Commission

The Conservation Commission is continuing work to prepare a Conservation Plan for the town, assisted by its consultant, Margaret Watkins. Responses to the Warner Conservation Questionnaire have now been tallied. This survey sought to find out about community attitudes and priorities regarding conservation activities in Warner. A total of 154 residents of Warner answered the questionnaire, a response rate of about 11 percent. Next, the Commission plans to invite members of several local organizations having an interest in outdoor recreation to participate in a focus group discussion on recreational issues as they relate to land conservation. A draft Conservation Plan is expected to be available for comment in October, with a final plan document in November. When completed, the Conservation Plan will become an integral component of the updated Town Master Plan. From the Planning Board

A subject residents will hear a lot more about this year and next is the WORKFORCE HOUSING LAW that was enacted by the Legislature in (Senate Bill 342) Chapter 299, Laws of 2008. Here is a brief statement that is contained in the law as adopted: *"The state of New Hampshire is experiencing a shortage of housing that is affordable to working households. This housing shortage poses a threat to the state's economic growth, presents a barrier to the expansion of the state's labor force, undermines state efforts to foster a productive and self-reliant workforce, and adversely affects the ability of many communities to host new businesses."*

This new law goes into effect January 1, 2010. All municipalities shall conform to the law. For us, that means that the Planning Board is required to create and place before the voters all necessary changes for our Zoning Ordinance and place them on the ballot for the March 2010 Town Meeting.

The Planning Board must also bring its Subdivision and Site Review Regulations into compliance with the new law. More coming on these items soon.

Our Town Master Plan Update has moved into Phase 2 with ongoing work in numerous areas of concern, such as; roads & streets; conservation topics; workforce housing; and many other issues.

Since the town must comply with State of NH Building Code Statutes, we will again place a warrant article before the voters to bring us into compliance.

The new one has a sheet feeder and can be set to make automatic double-sided copies. It has 25% to 400% zoom, and is also faster. Copies cost 10 cents. The report from an energy audit of the library building was recently completed. The Trustees will use the report to plan some energy-saving modifications in the coming year.

Our new activities for grades 5 to adult were well received and will be repeated next year. New Improved Online Warner Calendar of Events!

The Library, Selectmen's Office, Warner Connects, and Kearsarge Happenings (Warner Retailers) are collaborating on a calendar of local events and meetings that you can view online and print out in monthly, weekly or agenda format. If you have a personal Google calendar (available to anyone with a gmail or tds email account) or a device that uses iCal calendars, such as an iPhone or Blackberry, you can also copy selected events to your own calendar, ask for reminders to be sent, or send event details to other people.

A sample printout will be posted regularly on the new community bulletin board on the Town Hall lawn, but remember that new events are added frequently, so check the online version to be up to date. The goal is to include as many local happenings as possible, so people can go to one web page to get information about all kinds of activities, from children's programs, to dances, to sports, to Energy Committee meetings.

If you don't have access to the Web at home, visit the library to see it (staff can help you) or check the Community Bulletin board. The library will be offering tutorial sessions on using Google Calendars, in September. Demonstrations can also be arranged for a group or organization at a meeting.

Energy Committee News

The Town of Warner has been awarded an \$11,150 grant from the NH Public Utilities Commission to conduct energy audits of 9 Town and Precinct owned buildings. This is the first grant proposal submitted by the Warner Energy Committee. Our plan is to begin the audits this fall, with priority on the Town Hall and Old Graded School. The results of the audit will guide recommendations for future energy savings projects and grant requests.

Warner residents, who are interested in working on future projects are invited to attend our monthly meetings, which are scheduled for the first Thursday of each month at 7 pm at the Pillsbury Free Library.

From the Warner Village Water District

The Warner Village Water District has completed installation of wells on the properties of the four customers on North Village Road tied to the District's water main. This project was necessary because of an order by the NH Public Utilities Commission, prohibiting the District from terminating service unless an acceptable alternative was implemented. With the new wells now on line, the water main serving North Village Road has been shut off. The District is saving an estimated 3,000 gallons of water per day that was being lost through a blow-off, to maintain water quality for the four residences. The District is also experiencing a resulting decrease in electrical usage at the pump station due to the closing of this line.

On the sewage treatment side, the District's Superintendent, Jer Menard, implemented in April of this year a change in the operation that now utilizes both of the oxidation ditches simultaneously. Previously, the

ditches had been operated one at a time. The upside of this change is that the plant is functioning much better - according to its original design - with the result that the effluent is much clearer and there is less need to haul sludge to Concord's treatment plant, a considerable saving in hauling and disposal costs. The downside of the change has been the exposure of old equipment to a more constant usage. Recently, a number of nearby residents complained of the noise coming from the plant. The Superintendent had previously determined the noise was coming from the oxidation ditch motor that was failing after some thirty years of service. Jer had been trying different solutions to quiet the motor and as a last resort presented to the Commissioners the need to replace the motor at a cost of just under \$5000.00. In late July, the Commissioners authorized the purchase and installation of a new motor for the first oxidation ditch thereby eliminating the noise problem.

News from Emergency Management

H1N1 (Swine Flu): Human cases of an influenza A (H1N1) virus infection that has a swine component have been identified in the United States and New Hampshire. An investigation and response effort surrounding the outbreak of swine flu is ongoing on the national level and here in New Hampshire. The symptoms of swine flu in people are similar to the symptoms of seasonal flu in humans and may include: fever (greater than 100°F), sore throat, cough, stuffy nose, chills, headache, body aches, and fatigue.

This illness is spread from person to person and there is no risk of contracting this flu virus by eating pork. There are, however, some basic precautions that everyone should be taking to prevent becoming ill or spreading illnesses and not just swine flu. Stay home from work or school if you are sick. Cover your cough or sneezes with your sleeve and wash your hands frequently.

Warner is currently working with the Capital Area Public Health Network (CAPHN) to identify a Point of Dispensing to dispense the H1N1 vaccination if/when the State directs. The CAPHN website is keeping information, resource materials and press releases up to date.

WHAT TO BRING

Household cleaners; polishers; hobby chemicals; pesticides and herbicides; flea powder; pool chemicals; oil based paints (NO LATEX); solvents; varnishes; stains; paint remover; mercury containing devices such as thermometers and thermostats; adhesives; driveway sealer; photo chemicals; and miscellaneous other materials which are considered hazardous as waste. Look on the product for the warning labels such as caution, flammable, reactive, caustic or poisonous.

WHAT NOT TO BRING

LATEX paint is not considered hazardous, unless it is pre-1990 and labeled that it has mercury as a fungicide. Use kitty litter to dry out latex paint and then throw in your trash. It must be made into a solid to be considered solid waste. Empty, dry paint cans may be recycled as scrap metal at your recycling facility.

Alkaline batteries for flashlights and other household items are not considered hazardous and can be thrown in the trash. This includes most non-rechargeable batteries such as AA, AAA, C, D, and 9-volt batteries.

Automotive batteries can be exchanged, given, or even sold to local garages and auto parts stores. Used motor oil is collected at many town facilities or local garages.

Fluorescent light bulbs can be taken to most Ace and True Value Hardware stores for free. If your town collects them at your transfer station, it is cheaper for your town than bringing them for management at a hazardous waste collection.

Please do not bring ammunition and explosives, fire extinguishers, radioactive materials, or propane tanks. Contact your local police or fire departments about ammunition, explosives, and fire extinguishers. Smoke and carbon monoxide detectors can be sent back to the manufacturer. Propane tanks can be exchanged or refilled at a propane distributor.

Emergency Assistance Survey

If you or someone in your household might need help being notified of an emergency, sheltering-in-place, evacuating from home, or staying in a mass care shelter, please let us know.
