### Great Opportunities, Due Diligence and Hard Choices!

Towns, like families, often find that their needs and desires are sometimes greater than their resources for meeting these needs and desires. Warner is no exception and the Board of Selectmen is confronted with some hard choices as to what projects or acquisitions to support and what opportunities a town must forego. The Board of Selectmen have been hard at work performing the due diligence on a number of "Big Ticket" projects that the Town is obligated to address or is a potentially great opportunity for Warner. Here are a few projects the Board is working on and hope to present at Town Meeting:

1. Roundabout near Exit 9 - The engineering firm of McFarland/Johnson is completing the final design phase for the Roundabout and construction could begin after July 2015. This project is a State reimbursement program where the NH Dept. of Transportation reimburses the Town for 66% of the project cost. However, the Town has to raise about \$600,000 first and then receive \$400,000 from the NHDOT after the project is complete. The reimbursements from the State will go directly to the Town's general fund balance. The Selectmen's office is investigating financing options as well as potential tax impacts of securing and spending these funds within one year.

2. The New Fire Station - This spring, the Alternate Sites Committee met for six weeks reviewing suitable alternative sites for a new fire station. Using a set of criteria and qualifications for evaluating the suitability of a parcel as a potential site. The Committee reviewed and ranked over 30 parcels of land in town and presented the Board of Selectmen their four top ranked parcels. The Selectmen will hold a Public Information Session on Tuesday, October 21 at 7 pm at the Town Hall to share the results of their work and to seek public input on the two most favored parcels.

3. The Odd Fellows Building - Purchased by Town vote in 2000, this building contains hazardous waste that the Town is responsible for removing without any funding assistance from

the EPA. The Board is excited to now have a developer interested in making a major rehabilitation of the building. One of the greatest obstacles to converting this building into a viable piece of commercial real estate is the lack of parking spaces. The Board of Selectmen, spearheaded by Selectman Allan N. Brown's efforts, has received favorable interest from the Kearsarge Regional School District School Board to transfer some unused marginal land from school property abutting the Odd Fellows parcel to create 6 to 8 parking spaces. The Selectmen will present a plan to develop parking spaces for voter approval at the School District Deliberative Session in January. This plan will not only make the Odd Fellows Building much more viable to improve but will be a first step in addressing the lack of public parking in the Village area.

4. The Solar Panel Array Project: Selectman Clyde Carson, working with the Warner Energy Committee, has been investigating the feasibility of harnessing solar power to meet the Town's electric power needs. Recent legislation from Concord called 'Remote Net Metering' allows credits from generation of electricity from solar panels to be applied to any number of electric meters beyond the meter directly connected to the solar power generation station. This means that a municipality can build a solar panel array large enough to generate all the electrical power that it uses in all its buildings and facilities. The electric power is sold to the utility, which then credits (deducts) the electric usage costs for each Town meter.

Plummeting prices of solar panels along with the tax credits and grants that support construction of these solar arrays make this an attractive way to reduce energy costs. Barrington, Bedford and Peterborough are actively working on Solar Array Projects for their town facilities and other towns are now investigating into how to generate their own electric power. However, this is becoming a bit of a race because the NH Power Utilities Commission has placed a cap in the amount of kilowatt hours of power that can be generated and credited under this program and, given the intense interest, that cap may be reached quite soon.

## From the Conservation Commission

### Recycling is Mandatory in Warner

Everyone knows that recycling our waste, such as steel cans, scrap metal, aluminum, paper, plastic and glass, is smart because it reduces the waste that goes into landfills (or is incinerated). Recycled materials can also be re-used (or re-purposed), at a fraction of the energy required to mine or drill, refine and develop those materials from scratch. For example, aluminum made from recycled cans, uses 96% less energy, than if it were processed from bauxite ore (Hutchinson, 2008; Popular Mechanics). Similarly, plastic bottles can be made with 76 % less energy through use of recycled materials and newsprint, with 45 % less energy (Hutchinson 2008). Also, some products contain dangerous materials, like mercury in thermostats, batteries and fluorescent bulbs. By correct disposal and handling of these, we can ensure that harmful chemicals do not contaminate soil, ground water or become air pollutants through incineration and atmospheric deposition.

Recycling also makes economic sense for the residents of Warner because valuable materials, such as aluminum and steel cans that are thrown away in the large hopper, cost taxpayers twice. Once in the fees we pay each time we have the hopper hauled away (\$66.80/ton tipping fees plus \$12.50 transportation), but also in the lost revenue had we sold the aluminum to scrap metal dealers. Recycled aluminum cans recently fetched \$00.66 per pound (\$1320.00/ton) and light iron netted us \$205.00 per ton (V. Proper, pers. comm).



Backyard composting is another way to reduce the amount of waste we dispose of in the hopper. Why pay nearly \$80 per ton to have leaves, food scraps and tissue paper hauled away to a landfill, when you can turn those items into fertile, moist soil that plants thrive in? By some estimates, 90% of the material going to landfills has market value. Since we taxpayers, pay for each hopper that is hauled out of the transfer station destined for the incinerator (in Penacook, with ash going to a Franklin landfill), why not recycle more and throw away only what is necessary. If neighbors are NOT recycling, the rest of us are subsidizing their lack of effort.

Currently, our Transfer Station staff estimate that Warner is recycling about 26% of its waste material. Recycling makes sense environmentally and economically and per our town's Solid Waste Ordinance, is Mandatory. Come on Warner, we can do better than that and when we do, we will all save money, as well as energy, wildlife habitat and raw materials.

## Wood Bank Volunteer Day!

The Warner Community Wood Bank is having a volunteer day on Saturday morning, October 18th at 9:00 am at the Warner Transfer Station. Volunteers are needed to help stack wood as it is cut and split. ## Warner Rail Trail Opening

Saturday September 27<sup>th</sup> saw a great turnout to formally celebrate the opening of the Warner Rail Trail at Bagley Field and thank those who helped with improvements on this section of the railroad grade. We hope trail becomes a treasure for the residents of Warner. If you have not yet taken a walk on this section of trail please do so. Its flat and offers beautiful views of the Warner River and wildlife habitat. The trail begins at the Bagley Field driveway and proceeds for ½ mile. At the end there is a 600' path to the left which will bring you back to the main trail.

A year ago the town applied for, and was awarded, a \$5000 biking and walking grant from HEAL-NH. Thank you, HEAL-NH for administering the grant process and selecting the Town of Warner as a recipient. Thanks also to the NH Charitable Foundation Anonymous Fund for providing the funds.

The grant required a similar amount of matching funds. The trustees of the Nancy Sibley Wilkins Trust generously contributed \$2000 to the project. Thank you trustees for your willingness to support a grand vision at its earliest stage. Donations from residents provided another \$2000 towards the match. Thank you supporters!

Warner Parks & Recreation provided \$1000 to complete the match amount. Thank you, Parks & Recreation for your support. Your Parks & Recreation Department builds and maintains the park and recreation infrastructure in Warner for the enjoyment of all residents. Frequently the users of these facilities are youth programs run by WYSA and others, but it's important to realize these are your facilities as residents. Parks & Recreation's adopting the Rail Trail as a project to build and maintain is another example of how these facilities serve all of us.

Warner Parks & Recreation staff and volunteers did an incredible job cutting brush, trimming branches, removing dead wood, chipping and re-discovering the rail grade in the forest. Thank you again Warner Parks & Recreation: Alan Piroso, Griffin Manning, Joe Herr, Corey Heiligmann, Mark Allen, Kristen Riley, Alan Brown, Tim Blagden, and many others.

We needed to re-grade the surface before putting down stone dust and were having difficulty getting a contractor in when needed. The selectmen authorized DPW to come in and provide assistance. A huge thank you to the DPW crew for squeezing the work in and doing a great job. Matt, Nate, Tim the whole team thank you.

Thanks also to the Selectmen for their support. From their approval to apply for the initial grant to their help behind the scenes at many points along the way they deserve our sincere thanks. As town leaders the Selectmen have to balance many interests. Their support of a long term vision of a multi-use

trail usable by all citizens shows leadership. Where the town owns sections of the rail grade they are allowing the surface to be improved. Their actions set the example we hope others will follow when they consider if a trail being developed across their property is a benefit.

Much of the former rail grade is owned privately. Establishing a multi-use rail trail through town in many places is dependent on land owners choosing to participate. We hope that any residents who own part of the rail grade will like what they see at Bagley Field and want the trail to become passable across their property. Some have already decided to take that step. Thank you!

This trail will be developed in sections over time as landowners say yes and as we are able to raise the funds. We are working to open up another section at Bagley that will take residents over the river and offer a nice picnic spot on an old bridge abutment with a view up the Warner River.

The town has also applied for Transportation Alternative Program funds that would ultimately pay for 80% of the cost of a section connecting downtown Warner to the businesses Exit 9. While there is no guarantee Warner will prevail in that very competitive TAP application, fundraising is beginning now to raise the 20% match.

## Town Clerk News

The Town Clerk's Office will be closed Wednesday and Thursday, October 15 and 16 so that we may attend the New Hampshire City & Town Clerk's annual conference. Please plan accordingly, the office will be open regular hours Tuesday, October 12, 8 AM – 6PM.

On-line services are available on the Warner website (warner.nh.us) under the "Department" then "Town Clerk" tab. Scroll down to additional services to renew a registration, find out how much a renewal will cost or look up the cost of registering a new vehicle. Dog licenses are renewable on line and copies of a Birth, Marriage, Death or Divorce are available on line to those who are allowed by law to request them. Payments can be made by credit card or bank ACH.

Town Clerk's Office is now able to issue Hunting and Fishing licenses and OHRV registrations. This service is open to residents as well as non-residents.

November 4, 2014 is the date of the general election. Town Hall will be open for voting from 8 AM to 7 PM. If you are unable to come in person to vote, absentee ballot request forms are available from the Town Clerk's Office, the Secretary of State site and the Warner website. Please remember to bring a photo ID with you when you vote in person but if you do not have one with you, you can still vote if you complete an affidavit or are identified by an Election Official.

If you are a Veteran and want to have it stated on your driver's license then you can make that request on the application when you renew your driver's license and submit a DD214 (or other acceptable documentation from the list in RSA21:50). If it is not time to renew your license but you would like to add this information, you can go to a NH DMV Licensing Office with your document proof, complete the "Replacement License" form, mark the Veteran's indicator and pay \$3.00 for a new license.
