### 1994 Authorizes the Selectmen to Sell Property Taken for Taxes (Article 14)

To see if the Town will authorize the Selectmen to sell property taken for taxes by sealed bid or public auction or as justice may require after notifying abutting property owners of pending sale. This authority is granted indefinitely, until rescinded by Town Meeting

1994 Adopted RSA 202-A:4-c Library - Accept unanticipated revenue (Article 16)

## 1995 Authorizes the Selectmen to accept the dedication of any street in accordance with RSA 674:40 (Article 8)

To see if the Town will vote to authorize the Board of Selectmen to accept the dedication of any street in accordance with RSA 674:40 —a shown on a subdivision plat approved by the Planning Board, provided that such street has been constructed to applicable town specifications as determined by The Board of Selectmen or their agent. The Board of Selectmen shall refer proposed names of roads within the Town of Warner to the Naming of Roads Committee which shall in consultation with the Warner Historical Society, recommend to the Selectmen form approval by the Town names which possess historical association with the Town of Warner. This authority is granted indefinitely until rescinded by Town meeting.

1997 Adopted RSA 202-A:4-d Library - accept gifts other than money (Article 13)

## 1999 Authorizes the Selectmen to accept gifts of personal property (Article 26)

To see if the Town will vote to authorize the Selectmen to accept gifts of personal property which may be offered to the Town for any public purpose, pursuant to RSA 31:95-e. The Selectmen must hold a public hearing before accepting such gifts and no acceptance shall be deemed to bind the Town to raise, appropriate, or expend any public funds for the operation, maintenance, repair, or replacement of any such personal property. This authorization shall remain in effect until rescinded.

**2002 Authorizes** indefinitely, until specific rescission of such authority, the Selectmen to apply for, accept and expend, without further action by the Town Meeting unanticipated Grant money from a State, Federal or other governmental unit or a private source **(Article 18)** 

To see if the Town will vote to accept the provisions of RSA 31:95-b providing that any Town at an Annual Meeting may adopt an Article authorizing indefinitely, until specific rescission of such authority, the Selectmen to apply for, accept and expend, without further action by the Town Meeting unanticipated Grant money from a State, Federal or other governmental unit or a private source which becomes available during the fiscal year? This authorization will remain in effect into effect until rescinded by a vote at the Annual Town Meeting.

**2002 Article 19** – To see if the Town will vote to accept the provisions of RSA 33:7 providing that any Town at an Annual Meeting may adopt an Article authorizing indefinitely, until specific rescission of such authority, the Selectmen to apply for and issue Tan Anticipation Notes.

Shall the Town vote under RSA 31:39 to permit the Board of Selectmen to adopt bylaws on behalf of the Town of Warner until rescinded by a vote of the legislative body.

**2008 Town Hall Building Improvements Capital Reserve Fund (Article 16)** – Selectmen appointed as Agents to expend.

**2008 Transfer Station Acquisition & Improvements Capital Reserve Fund (Article 18)** – Selectmen appointed as Agents to expend.

Shall the Town vote to accept the provisions of RSA 79-D giving the Board of Selectmen authority to grant Discretionary Preservation Easements based on the specified areas spelled out under such chapter with the authority to remain in effect until rescinded.

## 2008 Authority to grant Community Revitalization Tax Relief (Article 22)

Shall the Town vote to accept the provisions of RSA 79-E giving the Board of Selectmen authority to grant Community Revitalization Tax Relief based on the specified areas spelled out in RSA 79-E-4 with such authority to remain in effect until rescinded.

# 2011 Authorizes the Selectmen to hold a public hearing before expending funds for Road Construction (Article 9)

Shall the Town raise and appropriate the sum of \$225,000.00 (Two Hundred Twenty Five Thousand Dollars) to be added to the already established Highway Road Construction Capital Reserve Fund? Of that sum \$100,000.00 (One Hundred Thousand Dollars) will come from the General Fund Balance with \$125,000.00 (One Hundred Twenty Five Thousand Dollars) being raised from taxation. Prior to any expenditure of funds, the authorized agent, the Board of Selectmen shall hold a duly noticed Public Hearing to fully explain what the money will be used for. Additionally, all funds expended shall be included in a report that is available for the public and included in the next year's Town Report. This amendment shall remain in force until rescinded by the legislative body.

**2011 Fire Rescue Vehicle Capital Reserve Fund (Article 12)** – Selectmen appointed as Agents to expend.

**<u>2011 Transfer Station Equipment Capital Reserve Fund (Article 15)</u> – Selectmen appointed as Agents to expend.** 

**<u>2011 Radio/Pager Expendable Trust Fund (Article 16)</u> – Selectmen appointed as Agents to expend.** 

## 2012 Authorizes the Selectmen to hold a public hearing before expending funds for Highway Equipment (Article 13)

Shall the Town raise and appropriate the sum of \$50,000.00 (Fifty Thousand Dollars) to be added to the already established Highway Equipment Capital Reserve Fund?

Motion to Amend:

Amend Article 13 as written by adding the following after Highway Equipment Capital Reserve Fund. All equipment purchases utilizing the Highway Capital Reserve Fund must be listed in the approved Capital Improvement Program for the year purchased unless an emergency requires that an existing piece of equipment be replaced due to breakdown. Prior to any expenditure of funds, the authorized agent, the

Board of Selectmen shall hold a properly noticed Public Hearing, as defined in State RSA, to fully explain what the money will be used for. Additionally, the Board shall vote to approve the expenditure of funds and all funds expended shall be included in a report that is available for the public and included in the next year's Town Report. This amendment shall remain in force until rescinded by the legislative body.

2012 Adopted provisions of RSA41:14-a. Acquisition or Sale of Land, Buildings or both (Article 28).

Selectman Brown moved to not use the PA-28 Taxable Inventory Forms and shall remain in effect until rescinded. Chairman Hartman seconded the motion; all were in favor, the motion passed.
